## 1. RULES

1.1. The regatta will be conducted in accordance with the 'rules' defined in the World Sailing Sailing Regulations.

1.2. Appendix P of the PRŻ, Special Procedures for Rule 42, shall apply.

1.3. The PZŻ regulations "Rules for the Organization of PZŻ Sailing Regattas" apply.

1.4. In the rules for this regatta:

[DP] denotes a rule for which the penalty is specified in the Introduction to the PRŻ - Note.

[NP] denotes rules that do not constitute grounds for a protest or a request for redress filed by a yacht. This amends Rule 60.1.

## 2. [DP][NP] ADVERTISING

Yachts may be required to display bow numbers and advertisements provided by the organizer.

## 3. CONDITIONS OF PARTICIPATION, ENTRY

3.1. The regatta is open to yachts of the classes specified in ZoR 4.1.

3.2. Entries must be submitted via the upwind24 platform (Information - POLISH CUP CLASSIFICATION REGATTA IN THE FINN CLASS | Upwind24).

3.3. The World Sailing Code of Eligibility applies to all competitors.

3.4. Final entries and payments may be made at the regatta office located in the container marked with a "Regatta Office" sign next to the clubhouse. The regatta office will be open from May 16 at 9:00 AM until the end of the regatta.

3.5. Competitors must have the following documents, which MAY be required during the registration procedure at

the regatta venue:

- a) proof of payment of the regatta entry fee,
- b) liability insurance with a minimum coverage of 1,500,000 EUR,
- c) parental/legal guardian consent to participate in the competition (applies to underage competitors),
- d) yacht certificate,
- e) a current medical examination, for competitors under 23 years of age,
- f) a current medical examination or a signed health declaration, for competitors over 23 years of age,
- g) PZŻ amateur or sports license,

h) PZŻ license for individual sponsorship (if applicable),

#### 4. ENTRY FEES

4.1. The entry fees for the regatta are as follows:

No.	Class	Entry fee until May 1, 2026	Entry fee from May 2–16, 2026
1.	FINN	350 PLN – two days	400 PLN – for two days

4.2. The entry fee must be paid to the PTTK Yacht Club account no.: 75 8448 0004 0020 2459 2056 0003 with the following in the payment description: First Name Last Name Goczałkowice Regatta 2026 – (class, e.g., Finn sail number POLxxx), or in cash at the Regatta Office. The entry fee amount depends on the date of registration on the upwind24.pl platform.

4.3. Competitors who do not complete the registration process by May 1, 2026 (inclusive) will be subject to a higher entry fee.

4.4. The regatta entry fee will not be refunded unless the organizer cancels the regatta.

#### 5. FORMAT

If more than 60 yachts are entered in a given class, the organizer may split the fleet. Classes that are split will compete in a qualifying series and a final series.

#### 6. SCHEDULE

6.1. Registration and race schedule:

6.2. No warning signal will be given after 1:30 p.m. on the last day of the regatta for which races are scheduled.

#### 7. EQUIPMENT INSPECTION

7.1. All yachts must be ready for equipment inspection starting at 10:00 on the first day on which races are scheduled.

7.2. Equipment inspection may also be conducted at any time during the regatta.

## 8. SAILING INSTRUCTIONS

The sailing instructions will be available on the official notice board located on the regatta office container.

## 9. REGATTA VENUE

9.1. The regatta will be held at the PTTK Pszczyna Yacht Club marina. Address: 5 Dębowa St., Wisła Wielka.

9.2. The races will take place on the waters of Lake Goczałkowice.

## 10. COURSES

10.1. The courses will be specified in the Sailing Instructions.

## 11. PENALTY SYSTEM

11.1. In addition to the rules marked [DP], the Sailing Instructions may contain standard penalties imposed by the race committee without a hearing. This amends PRŻ 63.1 and A5.

## 12. SCORING

12.1. The regatta will be considered valid after at least one race has been completed.

12.2. Scoring for individual age categories and competitions (if applicable) will be calculated based on the final results of the respective fleet.

12.3. If 3 or fewer races are completed, all of a yacht's results in the series of races count toward its final score.

## 13. SUPPORT CREW BOATS

13.1. All support boats participating in the regatta must be accredited by the regatta organizer during the registration process

13.2. All support boats must have liability insurance with a minimum coverage of 500,000 EUR, which must be presented during registration.

## 14. [NP][DP] MOORING SPOTS

14.1. All yachts and equipment must be moored in the locations designated by the Organizer.

14.2. The entry fee covers the cost of mooring yachts on the days scheduled for races and registration. If mooring extends beyond these dates, the yacht may be charged an additional fee

## 15. [DP] RADIO COMMUNICATION

Yachts participating in the race may not use radio transmissions, text messages, cell phones, or communication devices other than those provided by the Organizer.

## 16. AWARDS

The top 3 yachts in each class will be awarded prizes. The Organizer may change the number of prizes if fewer than 10 yachts enter a given class.

## 17. IMAGE RIGHTS

17.1. By registering for the regatta, the competitor agrees to:

- a) the free use of their image by the Organizers and sponsors in photographs, videos, and other reproductions during the regatta and in all materials related to the regatta,
- b) the processing of personal data contained in the regatta entry form for the purposes of conducting the competition by the personal data controller—the Polish Sailing Association, headquartered in Warsaw (03-901), al. ks. J. Poniatowskiego 1, has been informed that providing the data is voluntary but necessary for participation in the regatta and that he/she has the right to access and correct his/her data,
- c) publication of data (1) in a publicly accessible list: regatta results, start lists (1) Consent applies to the following data: - first name(s) and last name, - ID/license number and expiration date, - email address, - date of birth.

17.2. [DP][NP] Competitors may be required to give interviews during the regatta.

## 18. DISCLAIMER OF LIABILITY

All competitors participate in the regatta at their own risk. See Rule 3 'Decision to Participate in the Race'. The organizer assumes no liability for any damage, personal injury, or death incurred in connection with participation in the regatta, whether during the event or before or after it.

## 19. Accommodation Information

19.1 On the premises of the PTTK Yacht Club in Pszczyna:

Accommodation is available at the PTTK Yacht Club in four-person rooms with bunk beds. A fully equipped kitchen and a bathroom with a shower are available.
